**Title**

SUBSTITUTE - Amending Sec. 8.215(1) of the Madison General Ordinances to require users to obtain a permit prior to launching a boat or parking a vehicle or trailer in designated lake access parking lot areas.

**Body**

DRAFTER'S ANALYSIS: This substitute amendment requires users of designated lake access parking areas to obtain a permit prior to launching a boat or parking an accompanying vehicle or trailer in such parking areas.

The Common Council of the City of Madison do hereby ordain as follows:

Subsection (1) of Section 8.215 entitled "Use of Parks for Lake Access" of the Madison General Ordinances is

amended to read as follows:

"(1) No person shall ~~park~~ launch a motorboat, sailboat, iceboat, canoe, kayak or an all-terrain vehicle in designated lake access parking lot areas in Law, Marshall, Olbrich, Olin, Spring Harbor, Tenney and Warner Parks in the City of Madison ~~between January 1 and December 31~~ without first obtaining a lake access permit and paying the fee for same, which fee shall be established by the Parks Commission ~~subject to approval by the Common Council~~. Said permit shall be displayed in or on the launcher's accompanying motor vehicle in such location as designated by the Parks Commission."
