Fiscal Note

The proposed resolution recreates hourly Substitute Crossing Guard positions into a new compensation group. With this change, Substitute Crossing Guards will be eligible for step increases similar to Scheduled Crossing Guards. Substitutes currently earn an hourly rate of \$17.99. Under the new compensation group, Substitutes would start at \$17.91 per hour with a maximum step 4 amount of \$21.15 per hour. Additional wage costs from this change are not estimated to exceed \$2,600. This \$2,600 in additional costs assumes pre-Covid hours worked and all Substitute Crossing Guards at the max hourly rate. Traffic Engineering can accommodate any additional costs within its hourly wage budget for Crossing Guards.
