Title

To suspend the Class B Combination alcohol beverage license granted to Zapl, LLC, dba City Bar and Restaurant Adam Greenberg, agent, 636 State Street, Madison, Wisconsin, for three (3) days.

Body

WHEREAS, on or about June 5, 2007, a complaint was filed by Assistant City Attorney Jennifer Zilavy of the Madison City Attorney's Office alleging five (5) counts of PERMITTING UNDERAGE PERSON ON LICENSED PREMISE, in violation of Sec. 38.04(3)(B) of the Madison General Ordinances and two (2) counts of SELLING ALCOHOL BEVERAGES TO UNDERAGE PERSON, in violation of Sec. 38.04(1)(a)2, Madison General Ordinances, at the premises known as City Bar, 636 State Street, Madison, Wisconsin; and

WHEREAS, pursuant to Sec. 38.10 of the Madison General Ordinances, Assistant City Attorney Jennifer Zilavy and Attorney Frank Sutherland, on behalf of City Bar, entered into a stipulation regarding disposition of this case and agreeing that City Bar would have its Class B Combination alcohol beverage license suspended for a period of three (3) days; and WHEREAS, City Bar was assessed a forfeiture in the accompanying municipal court action in the amount of one thousand eight hundred ten dollars (\$1,810.00); and

WHEREAS, the parties agreed that City Bar employees would confiscate all false ID cards presented for entry into the establishment and present such confiscated ID cards to a member of the Madison Police Department's Central District Community Policing Team on a monthly basis; and

WHEREAS, the parties agreed that City Bar would provide brighter lighting in the area where bouncers check ID's and shall continue using a black light for verifying ID's; and

WHEREAS, the parties agreed that City Bar would have all employees attend the Madison Police Department's Tavern Safety Training by October 1, 2007, if they have not done so in the last two (2) years; and

WHEREAS, the parties agreed that because City Bar complied with the terms of the Stipulation, the three (3) day suspension is deemed served.

WHEREAS, the Alcohol License Review Committee approved the Stipulation of the parties.

NOW THEREFORE, BE IT RESOLVED, that the Common Council accepts the stipulation of the parties and the recommendation of the Alcohol License Review Committee and hereby agrees the three (3) day suspension of City Bar's Class B Combination alcohol beverage license is deemed served.
