He served one year with the City's Department of Administration as a Program Evaluator of the CDBG Program and began leading the CDBG Program in 1980; and

WHEREAS, Hickory's extensive knowledge of Community Development, especially Housing and Economic Development, has guided the development of healthy urban neighborhoods throughout Madison; and
