
The Common Council of the City of Madison do hereby ordain as follows:

Subsection (12) of Section 12.1515 entitled "Combination One Hour, 30 Minute and 15 Minute Parking Meter Zones" of the Madison General Ordinances is amended to read as follows:

On both sides of Mifflin Street from Henry Street to Fairchild Carroll Street and on the north side from Fairchild "(12) Street to Carroll Street and from Pinckney Street to Webster Street."

Subsection (16) of Section 12.1515 entitled "Combination Two Hour, 30 Minute and 15 Minute Parking Meter Zones" of the Madison General Ordinances is amended to read as follows:

On both sides of Mifflin Street from Webster Street to Butler Street and on the south side from Henry Street to



Broom Street and on the north side of Mifflin Street from Wisconsin Avenue to Carroll Street."
