WHEREAS, Great Neighborhoods South, LLC, has satisfactorily completed the installation of street improvements, **excluding the bituminous pavement**, on the streets listed below by private contract in accordance with the City of Madison Standard Specifications for Public Works Construction.

NOW, THEREFORE, BE IT RESOLVED, that the street improvements, **excluding the bituminous pavement**, on the following streets be and are hereby accepted:

- Canyon Parkway from the existing street easterly to the east line of Lot 124.
- Carncross Drive from the west plat line (existing street) to Bellingrath Street.
- Sledding Parkway from Bellingrath Street easterly to the existing street.
- Bellingrath Street from Sledding Parkway/Carncross Drive to the north line of Lot 72.
- Schutte Drive from the west plat line (existing street) to Bellingrath Street.
- Eagle Cave Drive from Bellingrath Street easterly to the existing street.
- Concrete sidewalk (6-foot wide) on Siggelkow Road adjacent to the entire frontage of Lot 124.

BE IT FURTHER RESOLVED, that the one-year guarantee shall have commenced on November 8, 2006.
