Title

WHEREAS, AT&T Corp. ("AT&T") has requested an easement for existing facilities located within the Stormwater Utility parcel at 7074 Reston Heights Drive; and

WHEREAS, AT&T's facilities are located in an area running parallel to and just south of the I-94 right of way, as depicted on attached Exhibit A; and

WHEREAS, City Engineering Division staff have reviewed and approve of the grant of such easement to AT&T.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and the City Clerk are hereby authorized to execute an Underground Telecommunications Easement to AT&T Corp. for the easement described as follows and depicted on attached Exhibit A:

The northerly ten (10) feet of Parcel 10 of Transportation Project Plat 1066-02-21-4.03 Amendment No: 1, being part of Outlot 15, Second Addition to the Meadowlands, Section 1, Town 7 North, Range 10

East, City of Madison, Dane County, Wisconsin.
