Fiscal Note

The proposed resolution amends the 2023 Parks Division Adopted Capital Budget and authorizes Amendment 1 and extends the contract term to April 30, 2024 for the existing consultant services contract with Sasaki Associates for the Lake Monona Waterfront project. Amendment 1 is for additional design, exploration, and project management associated with the proposed John Nolen Drive underpass and shoreline improvements. The proposed budget amendment adds \$200,000 in funding authority to the Parks Division’s 2023 Capital Budget for the Lake Monona Waterfront project (MUNIS #17362). The funding sources are \$100,000 in new City-issued General Obligation borrowing, \$90,000 in City-wide Park Impact Fee funding, and \$10,000 in private donation support. The new contract total, including Amendment 1, totals \$385,150.

Body

WHEREAS, in 2022, the Common Council authorized the formation of the Lake Monona Waterfront Ad-hoc Committee and approved holding a design competition for the Lake Monona Waterfront planning initiative (Legislative file#[68974 <https://madison.legistar.com/LegislationDetail.aspx?ID=5367173&GUID=6662C705-](https://madison.legistar.com/LegislationDetail.aspx?ID=5367173&GUID=6662C705-68974)

WHEREAS, the City issued a Request for Qualifications for professional planning team submissions to participate in the Lake Monona Waterfront Design Challenge; and

WHEREAS, the Ad-hoc Committee selected three consultant teams to participate in the Challenge; and

WHEREAS, the Ad-hoc Committee evaluated the team plan submissions, design challenge performance, and public survey responses; and

WHEREAS, based on the Ad-hoc Committee scoring, the City contracted with the Sasaki team to proceed with master plan development; and

WHEREAS, the Ad-hoc Committee and Sasaki continue to refine the Lake Monona Waterfront master plan based on committee, project stakeholder, and public comments; and

WHEREAS, the Ad-hoc Committee's dissolution date was revised from September 1, 2023, to the date of master plan submission to the Common Council, or March 31, 2024, whichever is soonest (Legislative File # 79642 <<https://madison.legistar.com/LegislationDetail.aspx?ID=6330320&GUID=DCC2AA04-2211-4AD1-8573-C3066224A033&Options=ID|Text|&Search=lake+monona+waterfront>>)

WHEREAS, the Ad-hoc Committee, working closely with the consultant design team, anticipates submission of the recommended master plan to the Common Council in the first quarter of 2024; and,

WHEREAS, the extended master plan timeframe requires additional services from the Sasaki design team; and,

WHEREAS, the Friends of Nolen Waterfront have pledged \$10,000 in private funding support for the contract amendment, AND

THEREFORE, BE IT RESOLVED, that the Parks Division's 2023 Adopted Capital Budget is amended to appropriate an additional \$100,000 of GO Borrowing, \$90,000 of City-wide Park Impact Fees, and \$10,000 in private donations, to the Lake Monona Waterfront project (MUNIS #17362); and

BE IT FURTHER RESOLVED, that the Common Council hereby authorizes the Mayor and City Clerk to execute Amendment #1 to the Contract between the City of Madison and Sasaki, Inc., in a form to be approved by the City Attorney, to provide additional consulting services for the work as described above.
