Fiscal Note

The three-tiered ticketing system provides additional leverage to ensure Parking fees due to the Parking Utility are paid. There is little impact on General Fund revenues, as few tickets are fully processed in lieu of the parking fees paid.

Title

Amending Sec. 1.08(3)(a) of the Madison General Ordinances to modify bail deposit amounts for failure to pay when exiting a municipal parking facility.

Body

DRAFTER'S ANALYSIS: This ordinance returns bail deposit amounts to a three-tiered system by which a parking citation is issued for failure to leave a parking facility without payment either attended or unattended. The citation amount is based on the amount of the parking fee when exiting.

The Common Council of the City of Madison do hereby ordain as follows:

Subdivision (a) of Subsection (3) entitled "Schedule of Deposits" of Section 1.08 entitled "Issuance of Citations for Violations of Certain Ordinances and Providing a Schedule of Cash Deposits" of the Madison General Ordinances is amended by amending therein the following:
