WHEREAS, the developer, Great Neighborhoods West, LLC, entered into a Contract for Subdivision Improvements for Cardinal Glenn - Phase I, on May 26, 2005, and,

WHEREAS, the developer wishes to complete the installation of sidewalk on South Point Road adjacent to the public stormwater detention basin (Outlot 11) as part of said contract, and

WHEREAS, in accordance with Section 16.23(9)(d)(6)(d), Madison General Ordinances, the City is obligated to reimburse the Developer, up to the statutory limit, for the installation of said sidewalk.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Clerk are hereby authorized to execute Addendum No. 1 to the Contract For Subdivision Improvements for Cardinal Glenn - Phase I, Contract No. 2028, with Great Neighborhoods West, LLC, and,
