**Fiscal Note**

The proposed resolution approves plan documents and authorizes receipt of bids for the 2019 CIPP Wet Lining rehab projects of sanitary sewer pipe at an estimated cost of \$1,295,000. The adopted 2019 capital budget for the Sewer Utility has appropriated \$1.5 million of sewer reserves and revenue bonds for the CIPP lining projects via the Trenchless Sewer Rehabilitation capital program.
