Fiscal Note

The proposed resolution approves plans and specifications for pavement replacement for Fish Hatchery Road at a total project cost of \$29,500,000. The proposed resolution authorizes the Mayor and City Clerk to enter into an agreement with the City of Fitchburg for cost sharing for this project. Under this cost sharing agreement, the City of Madison Engineering Major Streets would pay \$458,000, the Madison Water Utility would pay \$114,000, and the City of Fitchburg and Dane County would pay the remaining \$28,928,000. The 2020 Adopted Capital Budget includes funding for pavement replacement of Fish Hatchery Road under the Engineering Major Streets Pavement Management program (MUNIS 10540) and the Water Mains Replace Rehab Improve - Pavement Management program (MUNIS 11894).
