DRAFTER'S ANALYSIS: This ordinance changes the polling locations of Wards 99, 107, 114, 125, and 142 from Elver Park New Shelter to Our Redeemer Lutheran Church, the polling locations of Ward 126 from Madison Ice Arena to Falk Elementary School, and the polling locations of Wards 121, 122, 123, and 124 from Elver Park New Shelter to Madison Police Department-West District.
