Fiscal Note

Title

Creating Section 38.06(12)(d)1.h. of the Madison General Ordinances to add a provision that if an application for an 18+ Centers For Visual and Performing Arts license is denied by the Alcohol License Review Committee, the applicant is prohibited from reapplying for the same license for twelve (12) months from the date the application is denied.

Body

DRAFTER'S ANALYSIS: This amendment is to prevent repeated 18+ entertainment license applications from being submitted to the ALRC and to discourage businesses from altering their business plans in order to obtain an entertainment license when the entertainment license is not an integral part of the business.

The Common Council of the City of Madison do hereby ordain as follows:

Subparagraph h. of Paragraph 1. of Subdivision (d) entitled "Application" of Subsection (12) entitled "18+ Centers For Visual And Performing Arts" of Section 38.06 entitled "General Provisions and Hours" of the Madison General Ordinances is created to read as follows:

"(h) If the ALRC denies a 18+ Centers For Visual and Performing Arts license application, the applicant is prohibited from reapplying for another entertainment license for a period of twelve (12) months from the date the application is denied."
