She is a Board Member of Downtown Madison, Inc., and the Greater Madison Convention & Visitors Bureau.*

Mr. Schreiber and his firm have a long history of being engaged in downtown and neighborhood Madison projects. Representative examples of downtown Madison area projects are James Madison Park, the Monona Terrace Convention Center, Olin Terrace Park and Martin Luther King Boulevard. He is currently working with the City on possible art pieces for the proposed Central Park project. He is a member of the Rotary Club of Madison since 2004 and is the club's choice as their representative on the committee. He has done extensive work already for this project, preparing initial visual designs and working with Archie Nicolette in the City's Planning department on the design of the entire Plaza space.*
