Fiscal Note

This Ordinance (in conjunction with several others) makes permanent the metered parking on the Capital Square, following the 180-day trial period. All costs and revenues are recognized in the Parking Utility operating budget.

Title

Amending Subsection (12) of Section 12.1515 entitled Combination One Hour, 30 Minute and 15 Minute Parking Meter Zones and amending Subsection (16) of Section 12.1515 entitled Combination Two Hour, 30 Minute and 15 Minute Parking Meter Zones of the Madison General Ordinances (portion of Mifflin St.).

Body

DRAFTER'S ANALYSIS: This ordinance revises the Combination One Hour & Two Hour, 30 Minute and 15 Minute Parking Meter Zones on Mifflin Street.

The Common Council of the City of Madison do hereby ordain as follows:

- Subsection (12) of Section 12.1515 entitled "Combination One Hour, 30 Minute and 15 Minute Parking Meter Zones" of the Madison General Ordinances is amended to read as follows:
 "(12) On both sides of Mifflin Street from Henry Street to ~~Fairechild Street~~ Carroll Street and on the north side from ~~Fairechild Street to Carroll Street~~ and from Pinckney Street to Webster Street."
- Subsection (16) of Section 12.1515 entitled "Combination Two Hour, 30 Minute and 15 Minute Parking Meter Zones" of the Madison General Ordinances is amended to read as follows:
 "(16) On both sides of Mifflin Street from Webster Street to Butler Street and on the south side from Henry Street to

Broom Street and on the north side of Mifflin Street from Wisconsin Avenue to Carroll Street."
