Fiscal Note

This project will be included in the Fire Department's 2007 Capital Budget request. The total project cost is \$312,306, with grant funding of \$249,845 and G.O. funding of \$62,461 to meet the 20% match requirement.

Title

Accepting a grant if awarded from the Federal Emergency Management Agency, Department of Homeland Security (DHS).

Body

A grant application has been submitted to the, Federal Emergency Management Agency (FEMA), DHS for the Fire Department. The federal share of this grant if awarded is \$249,845 and the City share would be \$62,461. The City share is 20 per cent of the project cost of \$312,306.

The application was submitted for the following items:

1. Fire sprinkler systems for three of our seven fire stations that lack sprinkler systems. These systems will provide for the protection of Fire personnel health and safety, protect equipment/buildings and citizens when attending meetings and/or voting at fire stations.
2. Five Thermal Imaging Cameras to address the need for a camera on every first-in ladder or engine. The Department would be fully equipped with cameras when responding to all emergency incidents.

The grant budget is:
