WHEREAS the Madison Arts Commission's mission is to make the arts and essential part of the lives of all of Madison's citizens; and

WHEREAS the Common Council adopted ID Number 00293, authorizing the Mayor and the City Clerk to execute an amended agreement for design, fabrication, and inspection of installation between the City of Madison and Flow Forms America, Inc for creating site specific public art features that replace the four round brick fountains on the Capitol Square and the round brick planters at Wisconsin Avenue and Mifflin Street; and

WHEREAS one of the conditions of the contract requires that upon completion of each work (Wisconsin Avenue Planters, East Washington Fountains, West Washington Fountains) and other documentation being submitted by the artist, that the City of Madison will accept ownership of each work; and

WHEREAS the Capitol Square Fountains located at Carroll and West Washington Streets have been completed and the required documentation has been filed with the City.
