### Title

Amending the Master List of Street Names and Designations and amending the City Engineer's Street Numbering Map, referred to in Sections 10.34(1) and 10.35, Madison General Ordinances. Changing the names of various streets in the Village at Autumn Lake plat: Arial Spring Trail to Merry Maddy Lane; Snowberry Court to Wood Sorrel Court; Snowberry Street to Wood Sorrel Street. (17th AD)

### Body

**WHEREAS**, the Common Council, by Resolution No. 12,459, adopted March 9, 1967, has established a general policy on street names and approves a master list of existing street names and designations for all purposes; and

**WHEREAS**, a copy of Resolution No. 12,459 is made part of this resolution; and

**WHEREAS**, Secs. 10.34(1) and 10.35, Madison General Ordinances, require the City Engineer to maintain certain street numbering maps; and

**WHEREAS**, the plat of Village at Autumn Lake, was recorded March 30, 2006 in Volume 59-005B of Plats, Pages 20-39, as Document No. 4175683, Dane County Registry; and

**WHEREAS**, said Village at Autumn Lake plat dedicated public streets known as Arial Spring Trail, Snowberry Street and Snowberry Court; and

**WHEREAS**, during final plat approval for Village at Autumn Lake, City Engineering requested proposed Arial Spring Trail street name be given a different name for either the north-south or east-west portion as platted; and

**WHEREAS**, general street name policy #4 from Resolution No. 12,459, adopted March 9, 1967 requires street name changes due to curvilinear changes in street geometry and the difficulty it presents to consistent house numbering; and

**WHEREAS**, Snowberry Street and Snowberry Court conflict with the existing City of Madison street name Snowberry Lane, which was dedicated in the plat of Linden Park on December 5, 2005; and

**NOW, THEREFORE, BE IT RESOLVED**, all that part of the street formerly known as "Arial Spring Trail" from the mid-point of the curve at Lots 1 and 39 east to Autumn Lake Parkway, as shown on attached Exhibit "A1", is hereby changed to "Merry Maddy Lane"; and

**NOW, THEREFORE, BE IT RESOLVED**, all that part of the street formerly known as "Snowberry Street" from Tranquility Trail to the north terminus at the north plat line of Village at Autumn Lake, as shown on attached Exhibit "A2", is hereby changed to "Wood Sorrel Street"; and

**NOW, THEREFORE, BE IT RESOLVED**, all that part of the street formerly known as "Snowberry Court" from Snowberry Street to the south terminus, as shown on attached Exhibit "A2", is hereby changed to "Wood Sorrel Court"; and

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, that the City of Madison Traffic Engineering Division is hereby authorized to make necessary signing changes in the field as a result of this street name change.
