Proclaiming an Emergency in accordance with Section 3.025 of the Madison General Ordinances for the timely repair of the collapsed 12 inch sanitary sewer main near Pennito Creek. (16th AD)

Body

Preamble

A City of Madison public sanitary sewer main, located parallel to and East of Dutch Mill Road, from Tradewinds Parkway to approximately 300 feet southerly, has failed. City crews have made temporary provisions to convey sewerage and protect the environment, but site conditions (groundwater) require an experienced Contractor to undertake permanent repair or replacement. The urgency of the situation dictates that the City proceed with permanent repair in a timely manner.

NOW THEREFORE BE IT RESOLVED, that the Mayor and Common Council hereby proclaim an Emergency in accordance with Section 3.025 of the Madison General Ordinances for the timely repair of the collapsed 12 inch sanitary sewer main near Pennito Creek.

BE IT FURTHER RESOLVED, that the City Engineer is directed to proceed with all steps necessary to complete a repair in a timely manner.
