**Fiscal Note**

The cost for the remainder of 2007 is approximately \$1,581 (or \$2,163 including benefits) and is not available in the Police Department budget. The Police Department expects to request an additional appropriation later in 2007, and the funding required for this reclassification will be included in that request. The projected annualized cost is \$2,014 (or \$2,755 including benefits) and will need to be included in future years' budgets.
