The Common Council of the City of Madison do hereby ordain as follows:

Paragraph 3275. of Subdivision (a) of Subsection (2) of Section 28.06 of the Madison General Ordinances is hereby created to read as follows:

"28.06(2)(a)3275. The following described property is hereby omitted from the C2 General Commercial District and C3 Highway Commercial District and added to the PUD(GDP) Planned Unit Development (General Development Plan)

District:

Lots 1, 2 and 3, and NE 50 feet of NW ½ of Lot 4 and NE 40 feet of SE ½ of Lot 4, Block 1, Oakland Heights, City of Madison, Dane County, Wisconsin. This parcel contains 19,515 square feet."
