2. Subdivision (b) of Subsection (1) entitled "Basic Salary Schedules By Compensation Groups" of Section 3.54 entitled "Compensation Plan" of the Madison General Ordinances is amended by recreating the classification of Police

Report Supervisor in Compensation Group 18, Range 05.
