#### **Body**

DRAFTER'S ANALYSIS: Rezone 625 East Mifflin Street.

WHEREAS, an Amended PUD(SIP) Planned Unit Development (Specific Implementation Plan) District has been duly filed for approval of the Madison Common Council and is hereby made an integral component of the zoning district regulations.

NOW, THEREFORE, the Common Council of the City of Madison do ordain as follows:

Paragraph 3282. of Subdivision (a) of Subsection (2) of Section 28.06 of the Madison General Ordinances is hereby created to read as follows:

"28.06(2)(a)3282. The following described property is hereby omitted from the PUD(SIP) Planned Unit Development (Specific Implementation Plan) District and added to the PUD(SIP) Planned Unit Development (Specific Implementation Plan) District:

Lot 1, Certified Survey Map Number 11919, as recorded in Volume 73 of Certified Survey Maps, on Pages 137-138, as Document Number 4238479, Dane County Registry, City of Madison, Dane County, Wisconsin, containing 31,437 square feet or 0.7217 acres."
