Cnare) in the permanent salary detail of the Planning Unit budget are repealed and recreated as Planner 2 in Compensation Group 18 Range 08 and Planner 3 in Compensation Group 18, Range 10, respectively, thereof. Be it further resolved that the incumbents shall be reallocated to said positions.
