Body

PREAMBLE:

The City is proposing to construct a new street between the intersection of CTH M and Valley View Road and the intersection of existing Pleasant View Road and Mineral Point Road (CTH S). Design will be funded with 100% local funds and that portion of the project near the intersection of Valley View Road and CTH M will be funded with 80% federal funds, 20% local funds. Construction of the new street north to Mineral Point Road (CTH S) will be funded with 100% local funds. The City Engineer has entered into a design engineering contract with Ayres Associates, Inc. A portion of the project may also be eligible for Federal Stimulus Funds.

The City Engineer recommends that several additional design services be undertaken by Ayres Associates, Inc. They are:

- 1. Revise geometrics and preliminary plans for Pleasant View/Valley View/CTH M roundabout and finalize design to accommodate future expansion without reconstructing the entire roundabout.
- 2. Revise environmental assessment and other project development documents regarding changes in Pleasant View/Valley View/CTH M roundabout.
- Revise environmental assessment of southbound lanes on Pleasant View Rd.
