The position, effective July 1, 2009, is authorized in the 2009 adopted operating budget of the Economic Development Division. Funding of \$38,136 in salary, plus benefit expense, for a half year's expense is included in the 2009 EDD budget.

Whereas the Mayor's Executive Budget for 2009 includes a position tentatively titled "CDA Redevelopment Mgr." in the Department of Planning & Community & Economic Development, Economic Development Division budget, and

Whereas the CDA Redevelopment Mgr. position was not assigned to a compensation group and range, necessitating a study of the position's appropriate classification and range,

Now be it resolved that the position tentatively titled CDA Redevelopment Mgr. be appropriately classified as a Community Development Project Manager in Compensation Group 18, Range 12, in the permanent salary detail of the Economic Development Division thereof.
