Fiscal Note

The total project cost is \$529,210, with grant funding of \$423,368 and City funding of \$105,842 (G.O. borrowing of \$98,000 and \$7,842 of levy support) to meet the 20 percent match requirement. This project will be included in the Fire Department's 2010 Capital Budget and Operating Budget requests.

Title

Accepting a 2009 Assistance to Firefighters Grant if awarded from the Federal Emergency Management Agency, Department of Homeland Security (DHS).

Body

A grant application has been submitted to the Federal Emergency Management Agency, DHS for the 2009 Assistance to Firefighters Grant. The requested grant budget is \$529,210. If the grant is awarded the federal grant share would be 80 percent or \$423,368 and the City share would be 20 per cent or \$105,842. The grant application includes a Mobile Fire Training Center (which includes several training simulators) for training of personnel, personal protective equipment and medical exams.
