Title

Amending Sec. 31.04(2)(a) of the Madison General Ordinances to correct references to state laws as they relate to signs within 660 feet of certain interstate highways.

Body

DRAFTER'S ANALYSIS: This ordinance makes a correction to clarify the relationship between the City's sign ordinance and state laws that govern signs visible from interstate highways. TRANS 200 only applies to signs on highway right-of-way and need not be referenced in this section, and only certain parts of TRANS 201 are applicable within the City. This amendment preserves the original intent of this section.

The Common Council of the City of Madison do hereby ordain as follows:

Subdivision (a) entitled "Signs Located Near Interstate Highways" of Subsection (2) entitled "Application of Other Laws" of Section 31.04 entitled "Administration, Enforcement, and Construction Requirements" of the Madison General Ordinances is amended to read as follows:

"(a) Signs Located Near Interstate Highways. All signs hereafter erected within six hundred sixty (660) feet from the edge of the interstate highway easement or property measured horizontally along a line normal or perpendicular to the center line of the interstate highway shall be subject to the applicable provisions of Wis. Stat. § 84.30 and Wis. Admin. Code §§ Trans. 201.01, 201.04, and 201.05, in addition to being subject to this ordinance. Wis. Admin. Code § Trans 200 and 201 shall supersede any conflicting provisions of this ordinance. In the event of a conflict between Wis. Stat. § 84.30 and this ordinance, the more strict provision shall apply."
