Amending Sections 15.02(16), (17) and (118) of the Madison General Ordinances to change the polling location for Wards 16, 17 and 118.

Body

DRAFTER'S ANALYSIS: This ordinance changes the polling location for Wards 16, 17 and 118 from Streets East to HyVee.

The Common Council of the City of Madison do hereby ordain as follows:

1. Subsection (16) entitled "Ward 16" of Section 15.02 entitled "Wards and Ward Boundaries" of the Madison General Ordinances is amended by amending therein the following:

"For purposes of the November 4, 2008 election and for all elections thereafter, the polling location will be ~~Streets East, 4602 Sycamore Ave~~HyVee, 3801 E. Washington Avenue."

2. Subsection (17) entitled "Ward 17" of Section 15.02 entitled "Wards and Ward Boundaries" of the Madison General Ordinances is amended by amending therein the following:

"For purposes of the November 4, 2008 election and for all elections thereafter, the polling location will be ~~Streets East, 4602 Sycamore Ave~~HyVee, 3801 E. Washington Avenue."

3. Subsection (118) entitled "Ward 118" of Section 15.02 entitled "Wards and Ward Boundaries" of the Madison General Ordinances is amended by amending therein the following:

"For purposes of the November 4, 2008 election and for all elections thereafter, the polling location will be ~~Streets East, 4602 Sycamore Ave~~HyVee, 3801 E. Washington Avenue."
