#### **Fiscal Note**

Costs for the remainder of 2009 are estimated at \$472 (or \$653, including benefits). Funds are available within the 2009 Public Health Adopted Operating Budget. The projected long term annualized cost is \$7,590 (or \$10,497, including benefits). Funding for 2010 will be accommodated by the management of salary savings. Funding for 2011 and subsequent years will be included in the Public Health Requested Operating Budgets.
