Timothy Bruer, visited Camaguey to celebrate this anniversary and the designation of Camaguey's historic city center as a World Heritage Site by UNESCO; and

WHEREAS, the Madison-Camaguey Sister City Association and the Wisconsin Medical Project have invited noted Camagueyan artists, painter Orestes Larios Zaak and sculptor Gregorio Perez Escobar, as well as curator Maria Ofelia Granela Suarez to Madison in observance of this Anniversary; and
