DRAFTER'S ANALYSIS: Rezone 801 South Park Street.

The Common Council of the City of Madison do hereby ordain as follows:

1. Paragraph 3464. of Subdivision (a) of Subsection (2) of Section 28.06 of the Madison General Ordinances is hereby created to read as follows:

"28.06(2)(a)3464. The following described property is hereby omitted from the C2 General Commercial District and added to the PUD(GDP) Planned Unit Development (General Development Plan) District: Plat of West Bay, Lots 1, 2 & 3 except that part conveyed to the State of Wisconsin in Volume 501, Page 141, recorded 8/5/1947 as Document 749554 & re-recorded 12/5/1947 Volume 507 Page 249 Document 756494.
