The grant covers the metropolitan area which includes Dane County. The focus areas for this program are interoperable communications, medical supplies, training, exercises, mass care, resource data bases. pharmaceutical supplies, Mental Health Response Team, Medical Reserve Corp Program, planning and patient tracking.
