#### Title

To SUSPEND the handcrafted goods, personally prepared food vending restrictions and INVALIDATE Mall/Concourse vending licenses from 6:00 p.m. July 9 to 9:00 p.m. July 11, 2010, in the areas specified below for the benefit of the Madison Museum of Contemporary Art, so that the 52nd Annual ART FAIR ON THE SQUARE may occur.

### **Body**

WHEREAS, Section 9.13(6) of the Madison General Ordinances and the regulations adopted therein control street vending on the State Street Mall/Capitol Concourse area; and

WHEREAS, Section 9.13(6)(k)1. allows the Common Council to suspend specifically enumerated vending ordinances or regulations and establish alternate rules and procedures during a special event; and

WHEREAS, Section 9.13(6)(k)3. authorizes the Common Council to invalidate street vending licenses, Mall/Concourse Vending Licenses and sidewalk cafe licenses within the perimeter of a special event in order to encourage the integrity, comprehensiveness, and success of a special event; and

WHEREAS, the 52nd Annual ART FAIR ON THE SQUARE is such a special event; and

WHEREAS, the Madison Museum of Contemporary Art, as sponsor of the event, agrees to obtain a Street Use Permit for the setup and conduct of this event from 6:00 p.m. July 9 to 9:00 p.m. July 11, 2010, and agrees to comply with the conditions of the permit, including but not limited to any conditions placed on the permit by the Street Use Staff Commission; and

WHEREAS, the sponsor of the event, the Madison Museum of Contemporary Art wishes to insure the integrity, comprehensiveness and success of the 52nd Annual ART FAIR ON THE SQUARE by retaining control over the vending of both goods and food, and has demonstrated that special conditions exist which warrant such action by the Council; and

WHEREAS, the sponsors agree to comply with all recommendations of the Street Use Staff Commission and the Vending Coordinator concerning the location of vending sites and use of electricity; and

WHEREAS, street vending or Mall/Concourse vending licenses will be invalidated at this location not more than ten times in the year 2010, including this event;

NOW, THEREFORE, BE IT RESOLVED, that the Common Council hereby SUSPENDS the vending restrictions relating to handcrafted goods and personally prepared food set forth in 9.13(6)b of the Madison General Ordinances for the participants in the event on the above-mentioned dates and times on the following portions of streets and sidewalks:

Capitol Concourse - comprised of the 10 blocks of N. and S. Pinckney, the 10 blocks of N. and S. Carroll St., the 10 blocks of E. and W. Mifflin St., and the 10 blocks of E. and W. Main St.

100 block of E. and W. Washington Ave.

100 block of Wisconsin Ave. and 100 Marin Luther King Jr. Blvd.

100 block of State St. and King St.

100 block of E. and W. Mifflin

100 block of E. and W. Main St.

100 block of N. and S. Carroll

100 block of N. and S. Hamilton

100 block of N. and S. Pinckney

BE IT FURTHER RESOLVED, that any vending taking place within the above-described streets and sidewalks from 6:00 p.m. July 9 to 9:00 p.m. July 13, 2010, shall be limited to food, beverages, goods, and promotional items (such as t-shirts, posters, and souvenirs) which are related to the purpose of the event;

BE IT FINALLY RESOLVED that the Common Council herby INVALIDATES all Mall/Concourse vending licenses, with the exception of sidewalk cafe licenses, within the above-described streets and sidewalks from 6:00 p.m. July 9 to 9:00 p.m. July 11, 2010.
