BE IT RESOLVED,

WHEREAS, Steve Schlafman owns the property at 2702 N. Todd Drive, and;

WHEREAS, Mr. Schlafman contracted and paid for the removal of an underground storage tank (UST) from the public right-of-way at said property on September 2, 2009, in accordance with Comm 10 Guidelines, and;

WHEREAS, the City of Madison adopted Resolution No. 49,215 (ID No. 11,777) on September 1, 1992, establishing a policy to reimburse property owners one-half the cost of their out of pocket expenses which are not otherwise reimbursed for such UST removals, and;

WHEREAS, the total cost for said UST removal was \$5,155.00.

NOW, THEREFORE, BE IT RESOLVED, that the City Engineer is hereby authorized to disburse \$2,577.50 to Steve Schlafman for one-half the cost to remove a UST from the public right-of-way at 2702 N. Todd Drive.
