Relating to Green Cab of Madison's Taxicab Operator License Application.

Body

WHEREAS, Green Cab of Madison has applied for a taxicab operator license, and 11 zone (vehicle) permits in 2010 and an additional 10 zone permits in 2011;

WHEREAS, Green Cab of Madison with be the first new general service taxicab company in the City of Madison in about 24 years;

WHEREAS, the Division of Traffic Engineering has completed a thorough investigation of and concluded that the company meets eligibility criteria as listed under MGO (11.064 (b);

WHEREAS, the Common Council approves Green Cab of Madison's application to operate taxicabs and approves its request for 11 zone (vehicle) permits in 2010 and an additional 10 zone permits in 2011;

NOW, THEREFORE, BE IT RESOLVED, that Green Cab of Madison is issued an operator's license and 11 zone (vehicle) permits in 2010 and an additional 10 zone permits in 2011, subject to the provisions and conditions as stated above and the ordinances of the City of Madison.
