## **Fiscal Note**

This resolution creates a new 1.0 FTE limited term position of Architect 2 in the Engineering Division budget, and provides funding for this position for the remainder of 2010. Costs for the current year are estimated at \$25,150 of salary and \$10,285 of benefits, for a total of \$35,435. All costs would be billed to the Central Library Project, capital budget account #810611. There is no additional appropriation required in 2010. Additional work may be required in 2011 to complete this project, and additional funding as appropriate will be included in the Engineering Division 2011 Requested Operating Budget.
