#### **Fiscal Note**

The projected cost for the remainder of 2010 is approximately \$1,070 (or \$1,500 including fringe benefits) assuming the position is underfilled as an Accountant 1 as planned. This additional cost will be absorbed within the Comptroller's Office budget. The estimated annualized cost is \$6,230 (or \$8,780 including fringe benefits) at the Accountant 1 level and \$11,520 (or \$16,230 including fringe benefits) at the Accountant 2 level.
