Fiscal Note

The estimated cost in 2010 is \$72, including \$51 for salary, plus \$21 for benefits. Funding will be accommodated within the budget of the Office of the Director of Planning and Community and Economic Development. The full, annualized cost in 2011 is estimated at \$1,273, including \$903 for salary, plus \$370 in benefit expense. Funding is included in the 2011 Executive Budget.
