Proposed Use: Rezoning to Facilitate Future Residential Redevelopment; 3<sup>rd</sup> Aldermanic District: 4002 Nakoosa Trail.

#### **Body**

DRAFTER'S ANALYSIS: Rezoning 4002 Nakoosa Trail.

The Common Council of the City of Madison do hereby ordain as follows:

1. Paragraph 3507. of Subdivision (a) of Subsection (2) of Section 28.06 of the Madison General Ordinances is hereby created to read as follows:

"28.06(2)(a)3507. The following described property is hereby omitted from the M1 Limited Manufacturing District and W Wetland District added to the C2 General Commercial District:

Part of the SE ¼ of the SW ¼ and part of the SW ¼ of the SE ¼ of Section 33, Township 08N, Range 10E, City of Madison, Dane County, Wisconsin, more fully described as follows:

Beginning at the southeast corner of Certified Survey Map Number 9519, as recorded in Volume 54 of Certified Survey Maps, on pages 192-195, as Document Number 3172894, Dane County Registry, also being a point of curvature and a point on the west right-of-way line of Commercial Avenue; thence 140.38 feet along the arc of a curve to the right, also being said west right-of-way line, through a central angle of 09°36'15", a
