Fiscal Note

The overall cost to the City will be reduced by an estimated \$4,000 per year from the current rates for standard placements and special events as a result of the competitive bid. Funding for this contract is included in the 2011 Adopted Parks Division Operating Budget.

WHEREAS, the Parks Division currently utilizes approximately thirty portable toilets in a variety of Parks to provide restroom facilities to the public where no permanent structure is available; and;

WHERAS, the Parks Division utilizes portable toilets for special events managed by the Division, such as Ride the Drive and the Elver Fireworks; and;

WHEREAS, the current contract, expires on December 31, 2010; and;

WHEREAS, Purchasing Services, on behalf of the Parks Division solicited competitive proposals under RFP #8129-0-2010/SK, Portable Toilet Rental and Servicing.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and City Clerk are hereby authorized to enter into a
