### Fiscal Note

This grant, if awarded, requires a 20% match of \$1,508. The match will be funded through the Fire Department's 2011 budget or included in its 2012 budget, depending on the grant award year. No appropriation is required.

### Title

Accepting the 2010 Fire Prevention Grant if awarded by the Federal Emergency Management Agency (FEMA), Department of Homeland Security (DHS).

### Body

A grant application has been submitted to the Federal Emergency Management Agency (FEMA), DHS for the 2010 Fire Prevention Grant to fund a project on kitchen fire hazards. The project request is for a Fire Hazard Kitchen Simulator, educational materials and window graphics.

The project is 80% federal funds and a 20% match by the City of \$1,508. The budget is:
