WHEREAS, the following firms have applied for renewals of their taxicab "paratransit" licenses, effective July 1, 2011:

Affiliated Carriage Systems, Inc., dba Madison Taxi, requesting 47 meter taxicab permits and 4 airport shuttle taxicab permits

Badger Cab Company, Inc., requesting 43 zone taxicab permits

Green Cab of Madison Incorporated , 26 zone taxicab permits

Union Cab of Madison Cooperative, Inc. , requesting 71 meter taxicab permits

Badger Bus Lines, Inc., requesting 47 flat rate permits

Transit Solutions, Inc., requesting 28 flat rate permits and 1 airport shuttle permit
