### Title

SUBSTITUTE - Moving the classification of Weights and Measures Inspector 2 (CG16-R15) to CG16-R16, moving the classification of Weights and Measures Inspector 3 (CG16-R17) to CG16-R18, recreating position #677 of Weights and Measures Inspector 3, currently occupied by W. Sechrest, in CG16-R18 and reallocating the incumbent to the new position, and recreating the positions (#3941) of Weights and Measures Inspector 2, currently occupied by C. Lease (#3921) and currently vacant (#4335), as Weights and Measures Inspectors 3 and reallocating the incumbent of #3921 (C.Lease) to the new position, all in the Building Inspection permanent salary detail.

### Body

Resolution moving the classification of Weights and Measures Inspector 2 (CG16-R15) to CG16-R16, and moving the classification of Weights and Measures Inspector 3 (CG16-R17) to CG16-R18, thereof.

Resolution recreating position #677, currently occupied by W. Sechrest, of Weights and Measures Inspector 3 in CG16-R18 in the permanent salary detail of the Building Inspection Division budget and reallocating the incumbent to the new position, thereof.

Resolution recreating the positions (#3941) of Weights and Measures Inspector 2, currently occupied by C. Lease (**#3921**), **AND CURRENTLY VACANT (#4335)**, in the permanent salary detail of the Building Inspection Division budget as a Weights and Measures Inspector 3 and reallocating the incumbent **of #3921 (C. Lease)** to the new position, thereof.

**Fiscal Note**

The estimated cost for the reclassification of the Weights and Measures Inspector 2 for the remainder of 2011 is \$1,365 for salary expense, plus \$580 for benefits (\$1,945 total). The estimated cost for the reclassification of the Weights and Measures Inspector 3 for the remainder of 2011 is \$1,471 for salary expense, plus \$625 for benefits (\$2,096 total). The estimated additional annualized costs are \$9,070 for the Weights and Measures Inspector 2 reclassification (\$6,365 salary, \$2,705 for benefits) and \$3,245 for the reclassification of the Weights and Measures Inspector 3 (\$2,277 salary, \$968 for benefits). Funding for 2011 will be accommodated within the Building Inspection adopted salary and benefit expense budget.
