WHEREAS, Dan Stephans has led the Wisconsin Historic Preservation Office since 1998; and

WHEREAS, Dan Stephans has chaired the Wisconsin Historic Preservation Review Board for three terms; and

WHEREAS, Dan Stephans serves on the Board of Trustees for Taliesin Preservation, Inc., helping preserve the architectural and personal legacy of Frank Lloyd Wright; and

WHEREAS, these professional accomplishments reflect the knowledge and dedication Dan Stephans has brought to his volunteer service on behalf of the City of Madison; and
