### Fiscal Note

The Employment Agreement provides for an annual salary of \$117,235, plus benefits, effective October, 2011. The Metro Transit 2011 Adopted operating budget provides for salary expense of \$112,795, plus benefits. The difference between budgeted and actual expense in 2011 will be accommodated within the overall Metro salary budget, and the full salary will be included in future operating budgets.
