Fiscal Note

The net additional cost in 2011 is estimated at \$2,795 in salary expense, plus \$1,188 for benefits, or a total of \$3,983. The projected annual cost is \$14,540 in salary expense, plus \$6,180 for benefits, or a total of \$20,720. All funding is paid by Federal grants and will be accommodated in the CDD operating budget. There is no net impact on the levy.
