Approval to accept Homeland Security Metropolitan Medical Response System Grant 2010-HS-20-9231 awarded by the Wisconsin Office of Justice Assistance for \$301,548.

Body

The City of Madison Fire Department has received notification from the State of Wisconsin Office of Justice Assistance as to the award of a grant for the Metropolitan Medical Response System (MMRS) in the amount of \$301,548. The grant covers the metropolitan area which includes Dane County. The focus areas for this program are interoperable communications, medical supplies, training, exercises, mass casualty response, alternate care facilities; and patient care reporting and quality assurance. The grant approves the purchase of the Imagetrend Records Management System for all emergency response providers.
