WHEREAS Sylvia provided new employee orientation to the great majority of City employees since 1983, assuring thorough introduction to benefits and a positive first work experience; and

WHEREAS Sylvia's dedication and commitment to her work have earned the respect of those who have worked with her; and

WHEREAS she has provided order and sequence where none may have seemed apparent and has brought gentle good humor and understanding to discussions; and

WHEREAS Sylvia has been available to assist others as needed, including the Madison Fire Department in their selection processes, the Madison Parks Department as a Food Vendor Evaluator, and participants in
